Guidelines for recruitment of vacancies under National Health Mission

Applications are invited from eligible candidates in the prescribed application form for recruitment to the (4) UPHC Medical officers on contract basis (Multi zone I) initially for a period of (1) year and renewal will be as per the need and NHM yearly plan and subject to satisfactory performance. However every year new contract has to be signed and valid for the period as indicated in the contract.

- (4) Selection will be done on Merit Basis and based on the following criteria:
- (i) Total marks are 100 of which 90 marks will be allotted basing on the marks obtained in qualifying examination and 10 marks will be awarded for the age. Weight-age for age will be reckonedfrom18 years of age of the candidate.0.5 mark will be awarded for one completed year of age with a maximum of 10 marks. The age will be reckoned as on 01-07-2025. (Example 1. If a candidate completes 20 years as on 01-07-2025, he/she will be awarded 1.0 mark; Example 2.
