N.B.: The Appointment of retired Judicial Employees is subject to the following conditions:

- Only Persons who have retired as Chief Administrative Officers / Senior Superintendents / Superintendents of A.P. Judicial Ministerial Service will be considered for the post of Head-Clerk.
- 2. Ministerial Officers who have retired on attaining the age of superannuation and who have not attained the age of 65 years.
- 3. Ministerial Officers having satisfactory record of service and who are of sound health and active habits alone will be considered.
- 4. The candidates have to produce medical fitness certificate and should be physically and mentally fit to hold the post. The term of reemployment will be determined from time to time.
- 5. The employees who were dismissed, removed, compulsorily retired or made to seek retirement on medical grounds are not eligible for reemployment.
- 6. The employees who are re-employed shall be entitled to such consolidated remuneration as may be determined from time to time by the Government/Hon'ble High Court.
- 7. The re-employed shall be required to discharge their duties sincerely courteously and honestly to the satisfaction of the Presiding Officers.
- 8. The services of the re-employed employees are liable to be terminated at any time without assigning any reasons and without any notice and the appointment is purely temporary and on contract basis.
- 9. On appointment the appointees shall enter into an agreement with the concerned Unit Head initially for a period of one year, subject to renewal for a further period from time to time at the discretion of the Unit Head.
- 10. The applicants should submit their Service Certificates along with the applications obtained from the Officers where they last worked.
