 - ii. **Place of work:** SMC, GC New Delhi and frequent visits of Central Sports Teams concentrated at GC Sonapat, GC Jalandher, GC Kathgodam, GC Gurugram, GC-1&2 Ajmer, GC Rangareddy, GC Prayagraj, Chandigarh & other places in CRPF as per requirement.
 - iii. **Tax Deduction at Source :-** The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which TDS Certificate/Service Tax, as applicable will be issued .
 - iv. **Travelling Expenses:** - Travelling expenditures in connection with visit to Central Sports Teams outside NCR region will be provided. (By Train or Bus)
 - v. **Other Allowances:** - No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance/Transport, Personal Staff, Medical reimbursement, HRA and LTC etc would be admissible.
